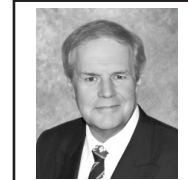

GREEN BIN COLLECTION

**Green Bin Collection Coming to East
Gwillimbury in mid-September**

In an effort to divert waste from landfill, Council has adopted three stream waste collection to commence in mid-September 2007.

Changes will include weekly green bin collection, weekly recycling collection, enhanced yard waste and white goods collection.

PROPERTY TAXES DUE

The interim 2007 property tax bills were mailed on January 16, 2007. Payment is due as follows:

1st installment due: February 28, 2007
2nd installment due: April 30, 2007

You may pay your tax bill at the Town office or at any chartered bank. You may pay your taxes by cash, cheque, post-dated cheque, direct debit, telephone/internet banking, or pre-authorized payment.

There are also two pre-authorized payment plans available:

Option #1 – Monthly Installment Plan
Withdrawal date is the 15th of each month.

Option #2 – Due Date Installment Plan

Please contact the Finance Department at 905-478-4282 ext. 229 if you did not receive a tax bill or wish further information about the pre-authorized payment plan.

All unpaid taxes will be charged an interest charge of 1.25% per month.

2007 YARD WASTE COLLECTION

If your regular Waste Collection Day is on **Tuesday or Wednesday** your Yard Waste Collection Dates are: **Monday, April 23rd, Monday May 28th, Monday June 18th, Monday July 23rd.**

If your regular Waste Collection Day is on **Thursday or Friday** your Yard Waste Collection Dates are: **Monday April 30th, Monday June 4th, Monday June 25th, Monday July 30th.**

Please place all Yard Waste out by 7:00 a.m. on your collection day. Yard Waste to be in kraft paper bags or open top re-useable containers. Yard Waste labels are available at the Civic Centre, Sharon at no charge.
