Subsection 81 (1) of the Municipal Elections Act, 1996, (Act) states:

“An elector who is entitled to vote in an election and believes on reasonable grounds that a candidate has contravened a provision of this Act, relating to election campaign finances may apply for a compliance audit of the candidate's election campaign finances.”

Reasons for applying for a compliance audit (attach any additional documentation)

Deadline for filing Application

The application must be made within 90 days after the latest of the filing deadlines, as described below.

- June 25, 2015 would be the last day to file a compliance audit request for the December 31, 2014 reporting period (regular campaign period filing deadline is 2:00 p.m. on Friday, March 27, 2015);
- December 24, 2015 would be the last day to file a compliance audit request for the June 30, 2015 supplementary reporting period if the candidate filed on the last day of the supplementary campaign period filing deadline of 2 p.m. on September 25, 2015, otherwise, the last day to file would be 90 days after the actual date of the supplementary filing;
- Another deadline as provided for in Subsection 79.1 of the Act (return of surplus for subsequent expenses), if applicable; or The expiration of a filing extension pursuant to Subsection 80(4) court ordered extension); if any

I understand that if the Compliance Audit Committee appoints an auditor to conduct a compliance audit of the candidate’s election campaign finances and the auditor’s report indicates that there was no apparent contravention of *the Act* and the Committee finds that there were no reasonable grounds for my application, the council is entitled under subsection 81(15) of the Act to recover the auditor’s costs from me. I make this solemn declaration conscientiously believing it to be true and knowing that it is of the same force and effect as if made under oath.
