COVID-19 Update - COVID-19 Update - On March 1, York Region opened up vaccine availability to those 80+. York Regional Police (YRP) Update - EG is protected by YRP's 1 District. Their priorities include improving road safety, engaging the community and youth, increasing police visibility, mental health response, and crime prevention. Broadband Update - While Broadband is not a municipal service, Council understands that this is an essential service for all residents. Council established the Broadband Working Group whose mission is to increase access to broadband throughout EG. In 2020, we saw significant fibre to the home expansion in Sharon and Mount Albert, with plans for new tower installations to support wireless connectivity anticipated. The Town is now working with an external consultant to complete a gap analysis and help develop strategies to support Internet Service Providers with expansion throughout EG. Town Grant Review - Over this Term of Council, the Town has leveraged over \$8 million dollars in Regional, Provincial and Federal grant funding. These grants have helped fund Town operations, infrastructure improvements and key capital modernization projects.

Tree Preservation/Removal - Beginning after March 8, tree removals will occur on lands west of Leslie Street in the new Queensville community. The Town requires replacement of all trees removed based on the size and type of tree.

Queensville Earthworks - As part of the next phase of development in the new Queensville community, earthworks will be ongoing on the west side of Leslie Street, just north of Doane Road. Work will include select tree protection and removal, clearing, topsoil stockpiling, importation of fill and grading. Work will begin in March and is expected to be complete in July.


PUBLIC SKATING AVAILABLE
