#### **Background**

The Town of East Gwillimbury launched the 2026 Business Plan and Budget Survey to better understand community perspectives on municipal programs, services, and priorities. The input and feedback collected will support informed decision-making, ensure that planning and budgeting reflect community needs and values, and help the Town understand current perceptions to enhance communication, transparency, and public awareness on how services are delivered and funded.

The survey was launched on July 28, 2025, following the start of the Town's business planning process, and will remain open until the end of Budget deliberations on November 26, 2025. The survey is available online through SurveyMonkey, or in-person at Customer Service desks. To raise awareness and encourage participation, the survey was promoted through various channels and tools, including the Town's website, social media accounts, eNewsletters, community Bulletin Magazine, Customer Service hold recordings, at Town events, and within library locations and other Town facilities through digital screens, banners, posters, and print material.

This survey represents one of several structured opportunities for community input. The Town has undertaken extensive consultation in creating its Strategic Plan, which now serves as the foundation for business planning. In addition, the Town and its Departments continuously engage residents, businesses, and other partners through master planning processes and project-specific initiatives. These consultations generate insights that are incorporated into planning, budgeting, and service decisions, ensuring that the Town remains responsive to evolving community needs and expectations.

The Town of East Gwillimbury has a population of approximately 41,000 residents with approximately 15,000 properties. The municipality is a balanced community made up of several growing urban areas and villages, covering an area of 238 square kilometres (91.89 square miles).






#### **Key Insights**

- As of October 16, 2025, the Town has received 147 survey submissions.
- Approximately two fifths of respondents (59) indicated that the **Town programs and** services represent fair value for property taxes paid, while 41 respondents indicated good or excellent value, and 44 indicated poor or very poor value.
- For the majority of Town programs and services, respondents overwhelmingly selected
  that service levels should be maintained, as opposed to increased or decreased. While
  respondents indicated strong support for service level increases in recreation programs
  and events and infrastructure repairs and replacement, fire and emergency services was
  the only category where increasing service levels received the most support.
- Almost one third of respondents (47) indicated that the Town should allocate tax dollars towards investing in new or expanded services to support growth and respond to resident priorities. Approximately one fifth of respondents (30) believe that taxes should be put towards maintaining or improving existing services. Over one quarter of respondents (44) believe that taxes should be reduced, even if it means reducing some services.
- Optional open-ended comments revealed the following key insights from respondents:
  - Widespread concern about recent property tax increases, affordability, and costof-living pressures.
  - Strong views to reinforce focus on core municipal services (e.g., water, roads, safety, emergency response) and prioritize essential services over discretionary initiatives.
  - Calls from Mount Albert residents for increased service equity and even distribution in infrastructure and recreation investments.
  - Notable divide between respondents seeking service enhancements (e.g., recreation, amenities, emergency services, transit options) and those calling for spending restraint.
  - Positive recognition of progress in parks and trails, recreation and library programming, and Town facilities.
  - Need for increased clarity on how the Town's share of property taxes is used and what services it funds, compared with Regional portion.

#### **Respondent Demographics**







How would you rate the value that you receive from the Town of EG (39%) portion of your tax dollars?





Based on your experience interacting with the following Town programs and services, please indicate what change in service levels you would support.



#### Survey Question: What is your top priority for how tax dollars are spent?






Survey Question: Which of the following best describes your experience with the Town's communication efforts on the Business Plan and Budget (select all that apply)?

#### **Property Taxes**

I looked at my banking app and my property taxes went up \$700 from 2023 to 2024!!!! Are you kidding me? I honestly don't care what the money is being spent on. Cost of living has exploded and you have increased property taxes that much?!? Please LOWER them!!

Anywhere you can save money please do! I don't want better parks or more programming! I want my property taxes back where they were. Cost of living has gone up considerably. In the same time frame our property taxes went up \$700!!!!!! Please stop doing that, my family can't afford it.

Not happy with the value for tax collected.

Why have our property taxes climbed 20 in the last four years and the town employees on the sunshine list gotten the same pay increase as our taxes increased when multiple other businesses sectors did not receive the same pay increases when families are struggling to make ends meet meet!

As we pay so so much in taxes, more should be put into our communities.

A smaller percentage should be alloted to York Region as all the region does is divert the money to larger towns leaving everyone else without.

I think that the region portion is way too high. More of our property taxes should go the municipality.
