The Operations Technologist is a diversified role that reports to the Supervisor of Operations Support and provides support to the Operations Branch of the Community Infrastructure & Environmental Services department. This position will coordinate and support initiatives related to ensuring compliance with the new Consolidated Linear Infrastructure Environmental Compliance Approvals (CLI ECA). Additionally, this position will administer Road Occupancy Permits (ROP) and Municipal Consents (MC) and will provide technical support to ensure compliance with applicable legislation and best practices related to Roads, Stormwater, Water, Wastewater, Solid Waste Management, and Streetlights. In addition, this position will support various programs and activities including, but not limited to, infrastructure locates, streetlight repairs, winter maintenance, sampling, data entry and analysis, research, GIS mapping, responding to customer service requests, and continual improvement initiatives. The position provides support and technical assistance with procuring supplies, equipment, and services as well as developing Council reports and developing workplans and operational programs.
