



## NOTICE OF COMPLETE APPLICATION & PUBLIC PLANNING MEETING

**EAST GWILLIMBURY TOWN COUNCIL will hold a Public Meeting to receive input on the above noted Planning Act application on:**

ANY PERSON may attend the public meeting to make written or verbal representation either in support of or in opposition to the proposed Planning Act application. You may attend the meeting in-person or by joining electronically. **APPLICATION(S):** The Owner has submitted Official Plan Amendment and Zoning By-law Amendment applications.

**PURPOSE:** The application proposes the development of a 13-storey purpose-built rental apartment building containing 142 residential units, comprising 90 one-bedroom and 52 two-bedroom units. The proposal includes four levels of above-grade parking with nine residential floors above. A total of 183 parking spaces are proposed, comprising 147 spaces for residents and 36 for visitors. Additionally, 48 bicycle parking spaces are included—44 indoor and 4 outdoor.

### Official Plan (O.Reg. 543/06) &

If you wish to be notified of the decision of the Town of East Gwillimbury on the proposed Official Plan Amendment, you must make a written request to the Town of East Gwillimbury to the attention of Pardis Zanjanchi, Planner – Development Services – Planning Branch.

If a person or public body would otherwise have an ability to appeal the decision of the Town of East Gwillimbury to the Ontario Land Tribunal but the person or public body does not make oral submissions at a public meeting or make written submission to the Town of East Gwillimbury before the proposed official plan amendment is adopted, the person or public body is not entitled to appeal the decision.

If a person or public body does not make oral submissions at a public meeting or make written submissions to the Town of East Gwillimbury before the proposed official plan is adopted or the by-law is passed, the person or public body may not be added as a party to the hearing of an appeal before the Ontario Land Tribunal unless, in the opinion of the Tribunal, there are reasonable grounds to add the person or public body as a party.

**Zoning By-law (O.Reg. 545/06)**

If you wish to be notified of the decision of the Town of East Gwillimbury on the proposed Zoning By-law Amendment, you must make a written request to the Town of East Gwillimbury to the attention of Pardis Zanjanchi, Planner – Development Services – Planning Branch.

If a person or public body would otherwise have an ability to appeal the decision of the Town of East Gwillimbury to the Ontario Land Tribunal but the person or public body does not make oral submissions at a public meeting or make written submission to the Town of East Gwillimbury before the proposed zoning by-law amendment is adopted, the person or public body is not entitled to appeal the decision.

If a person or public body does not make oral submissions at a public meeting or make written submissions to the Town of East Gwillimbury before the proposed zoning by-law amendment is adopted or the by-law is passed, the person or public body may not be added as a party to the hearing of an appeal before the Ontario Land Tribunal unless, in the opinion of the Tribunal, there are reasonable grounds to add the person or public body as a party.
