
# Heritage Programs should be about community value!


## The Heritage Conservation District Study (HCD Study)



## What is an HCD?

- Enabled by the Ontario Heritage Act (Part V)
- A municipal planning tool
- Conserves heritage and guides growth in historic neighbourhoods
- Based upon a required provincial approach which includes

an HCD Study followed by an HCD Plan





## What are some characteristics of an HCD?

- A concentration of heritage buildings, sites, structures and landscapes that are connected by aesthetic, historical and socio-cultural contexts or use.
- A framework of structured elements including major natural features and built form. Such as:
  - Topography, land form, landscapes, water courses,
  - pathways, street patterns, landmarks, nodes, intersections, approaches and edges.
- A sense of visual coherence that conveys a distinct sense of time or place.

 A distinctiveness which enables districts to be recognized and distinguishable from their surroundings or from neighbourhood areas.





## The HCD Study

- Considers the history, architecture/design, and landscape/context of a neighbourhood
- Considers issues affecting heritage in that area
- Determines if an HCD is the appropriate planning tool
- Relies on community input




#### The HCD Plan

- Outlines the specific objectives, policies and design guidelines of a Heritage Conservation District.
- Provides detailed heritage policies and guidelines for
  - new developments,
  - demolitions,
  - additions, and
  - modifications on heritage properties in an HCD





## HCD or Something Else?


- Different planning tools available.

- If Official Plan or Zoning By-law amendments are required











## More Homes Built Faster Act 2022 (Bill 23)

- Changes to HCDs
  - At least 25% of properties within a proposed HCD area must meet two or more O.Reg. 9/06 criteria
  - Municipal councils can amend HCD by-laws
  - Municipal councils can repeal HCD by-laws
